



Initiative Background

- ▶ Historically, Latino/a and Black men who have sex with men (MSM) and transgender women have continuously lagged behind more privileged and well-resourced White gay male populations in receiving information about the latest innovations in both HIV treatment and prevention.
- ▶ As a result, Latino/a and Black MSM and transgender women have not benefitted from early adoption of highly effective HIV innovations. This has contributed to the disparity in HIV that persists today in these populations.

Initiative Goals

- ▶ This Initiative seeks to address the delay in disseminating information on the latest HIV innovation, Long-Acting Injectable Pre-Exposure Prophylaxis (LAI PrEP), to Black and Latina/o transgender women and men who have sex with men (BLTW/MSM) in Los Angeles County.
- ▶ To do this, we are implementing a series of online community workshops to provide accurate and up-to-date information on LAI PrEP-related topics that are of relevance to BLTW/MSM consumers and their service providers.

What is Long-Acting Injectable PrEP?

Apretude (injectable PrEP) is the newest HIV prevention option

- ▶ FDA approved in December 2021
- ▶ 1 injection every 2 months
- ▶ To start: Optional oral tablets for 28 days
OR immediate injection
- ▶ Injection site: Muscle of buttocks

Los Angeles County PrEP Landscape



LAC Population

- 10.2 million residents
- Most populous county in the United States
- Greater population than 42 individual states
- One of the most racially/ethnically diverse counties in the United States
- 225 different languages are spoken
- 49.4% are male



It is estimated that **75,960** people in LA County would benefit from PrEP




Estimated Pre-Exposure Prophylaxis (PrEP) Use by Race/Ethnicity, LAC 2021




Note: PrEP coverage, reported as a percentage, was calculated as the estimated number of persons prescribed PrEP (numerator) divided by the estimated number of persons with an indication for PrEP (denominator). Different data sources were used to estimate values for the numerators (Division of HIV and STD Programs biomedical and sexual health service data [Los Angeles County (LAC) Department of Public Health Division of HIV and STD Programs (DHSP) 2021]; DHSP Online Dating Apps User Survey 2021 ; LAC National HIV Behavioral Surveillance survey data , DHSP, 2016-19); and the denominators (PrEP Populations Estimation Tool [CDC: shinyapps.io]; 2018 LAC Health Survey); LAC STD Surveillance, 2021, National Health and Nutrition Examination Survey [NHANES] 2021; LAC Census Data 2021)

- Most people who are indicated for PrEP are aware of it.
 - A recent survey of select LA County dating app users found 97% of participants were aware of PrEP.
 - However, only 42% of those same survey participants were using PrEP.



- Many healthcare providers are also aware of PrEP
 - 2020 national survey of primary care providers estimated that 90% were aware of PrEP
 - Among those same providers, 15.6% had ever prescribed PrEP, though 34% reported they would be likely to prescribe it in the next 12 months



Who can prescribe PrEP and PEP to patients?



- Any licensed prescriber can prescribe PrEP or PEP
 - Medical Doctor (MD)
 - Doctor of Osteopathic Medicine (DO)
 - Physician Assistance (PA)
 - Nurse Practitioner (NP)

Under California's law, SB 159 pharmacists are allowed to dispense PrEP without a prescription. A pharmacist can dispense 30 to 60 days of PrEP after testing and counseling. A pharmacist can also dispense a full 30-day course of PEP.

What keeps people from using PrEP?

- Lack of awareness of PrEP
- Stigma- PrEP, gender identity, sexual behaviors and sexuality in general
- Medical mistrust
- Fears or discomfort in talking to their doctor about it
- Underestimation of one's HIV risk
- Difficulty accessing PrEP
 - Their provider will not prescribe
 - Lack of insurance or cost concerns
- Significant negative social determinants of health

Social Determinants of Health

- More than 69,000 persons are homeless on any given night; a 31% increase since 2018
- Average daily inmate population is more than 14,500
- Fentanyl overdose deaths increased 1,280% from 2016 to 2021
- Methamphetamines accounted for 52% of all drug overdoses in 2020
- Opioid related deaths increased almost 11% between 2020 and 2021

LAC Population Health Insurance Status (2019)

- Medi-Cal Expansion
 - 2014: Expansion to broader population of low income adults (non-parent)
 - Further expansion **regardless of immigration status**:
 - 2020: Expanded coverage to children and young adults (up to 25 years)
 - 2022: Expanded coverage to adults 50 years and over
 - *2024: Planned expansion to adults 26 to 49 years*
- 2019, 33% Medi-Cal coverage
- 2023, 45% Medi-Cal eligible

PrEP services covered with no cost-sharing



- June 2019: United States Preventive Services Task Force (USPSTF) released a recommendation with a grade “A” rating that clinicians offer PrEP to persons who are at high-risk HIV acquisition.
- Under ACA, preventive services given a grade A are required to be covered without cost-sharing in commercial, employer, and public health plans.
 - Medical visits
 - Laboratory visits
 - Prescriptions
- USPSTF currently updating recommendations to include any formulation that is FDA approved for PrEP.

HEALTH CARE

Texas judge strikes down free HIV drugs, cancer screenings under Obamacare

The nationwide ruling holds that the health panel that decided what services insurers must cover is unconstitutional.



How can people access PrEP?



- For clients with health insurance:
 - PrEP and PEP are covered by private insurance (commercial, employer based) and public insurance (Medi-cal, Medicare)
 - Additional financial support from State PrEP-AP program and drug manufacturer copayment assistance programs
 - **LAI:** Coverage of LAI medication can be under the insurer's medical or pharmacy benefit
 - Medi-cal coverage straightforward

No PrEP Coverage? No Problem!



FREE or low-cost Pre-Exposure Prophylaxis (PrEP) to prevent getting HIV is available to all residents of LA County!

The following information provides an overview of how to access PrEP.



If You Have Insurance



Medi-Cal

- PrEP and all related medical services are 100% covered as preventive services.
- Services should be billed directly to Medi-Cal, not the patient's managed care plan.
- **Who is eligible?**
 - LA County residents whose income is at or below 138% Federal Poverty Level (FPL).
 - Undocumented individuals between the ages of 19-25 years qualify for full-scope Medi-Cal (SB 75).



Medicare

- PrEP is covered by Medicare with very low co-pays.
- Financial assistance through the California State PrEP Assistance Program (PrEP-AP) is available should individuals reach the coverage gap limit of \$4,430, commonly referred to as the "donut hole."
- **Who is eligible?**
 - Individuals 65 years old and older.
 - Individuals under 65, have a disability, and have received Social Security Disability Insurance (SSDI) for 24 months.



Private Insurance Purchased on The Health Exchange (Covered California)

- Covers the costs of medication and related medical services at no cost to the patient.
- Prior authorization may be required but must be expedited so patients can access it quickly.
- To get started with applying for Covered CA: www.coveredca.com
 - Open enrollment is usually in the Fall.
 - Enroll for Covered CA at any time if you meet one of the following qualifying life events: www.coveredca.com/support/before-you-buy/qualifying-life-events/
- **Who is eligible?**
 - People who are legal U.S. residents, permanent or temporary.
 - People who have amnesty visas (due to fleeing persecution).
 - People who have a worker or student VISA.
 - Income must be between the range of 138% - 400% FPL.
 - Consultation with a certified Covered CA Certified Insurance Agent is encouraged.



Private Insurance Through Work or Employment

- Most major insurance providers cover the costs of medication and related medical services at no cost to patients. Prior authorization is not needed.
- **Who is eligible?**
 - Individuals who are insured through their employer.

How can people access PrEP?



- **For clients who do not currently have health insurance:**
 - May be eligible for health insurance
 - Medi-Cal has robust coverage
 - Covered California plans may cover costs of PrEP (Bronze Plan poorest coverage)
 - PrEP-AP will pay for:
 - Approved PrEP-related medical services, such as doctor visits or labs
 - Temporary access period of 30 days – time to get appropriate documentation
 - Coverage for oral medication **if** the patient is under parent, or spouse, insurance plan and wants to access services confidentially.
 - Other medications on the PrEP-AP formulary used to treat STDs
 - Medications obtained through drug manufacturer's patient assistance programs (Gilead/Ready-Set-PrEP for name brand oral, ViiV Connect for LAI)

How can people access PrEP?



- DHSP funded **PrEP Centers of Excellence (COE)** which provide PrEP/PEP services at low to no cost for clients who meet financial eligibility.
 - 15 agencies with multiple locations
 - Income eligibility: Client's income must be at or below \$72,900/year
- **PrEP COEs** offer multiple services:
 - Navigation- applying for insurance or enrollment into patient assistance programs
 - Counseling/tips to help clients remember when to take their medications
 - Referrals to other services to keep clients healthy
 - Primary medical care

Minors (younger than 18) who want to access PrEP/PEP and are concerned about confidentiality can be referred to CHLA or the Alexis Clinic at LAC+USC



SB 427: Health Care Coverage of ARVs, Products, Devices for HIV Prevention

- Authored by Senator Anthony Portantino (Burbank/Pasadena)
- Sponsored by Insurance Commissioner Ricardo Lara
- Supported by Equality California
- Prohibits health insurers from imposing cost-sharing for ARVs, devices or products approved by FDA or recommended by CDC for the prevention of HIV
 - Projected to expand no-cost PrEP to one million Californians
- Referred to Senate Appropriations Committee
 - Hearing on May 8th

- Strategies: Committees, Senate and Assembly floor
- Governor strategy

Advocacy Strategies: Act

- Work with Senator's office
- Organization letters/community sign-letters
 - Submit through legislative portal no later than 1 week before committee consideration
- Meetings with key legislators/staff
 - Committee Chairs/Co-Chairs
 - Committee Members
 - Potential supporters/champions (LGBTQ Caucus)
- Action alerts/mobilize community
- Op-eds/letters to editor/social media
- Letters to Governor

SB 339: Health Care Coverage of ARVs, Products, Devices for HIV Prevention

- Authored by Senator Scott Wiener (San Francisco)
- Expands pharmacists' ability to furnish PrEP and PEP
 - Theoretically includes LAI PrEP
- Sponsored by Equality California, San Francisco AIDS Foundation, California Pharmacists Association
- Priority bill for End The Epidemics
