



# Medications for Addiction Treatment (MAT) Expansion Project




### What is the CA Hub & Spoke System?

- The CA Hub & Spoke System (CA H&SS) is a component of the California MAT Expansion project
- It is a State Targeted Response (STR) to the Opioid Crisis Grant program administered by SAMHSA
- Within a two year grant period, the MAT Expansion Program is projected to serve over 20,000 individuals with Opioid Use Disorder (OUD) to address the opioid crisis in California



#### **H&SS** Description

 Each Hub is connected to a number of Spokes, which is any office or clinic with a buprenorphine prescriber. The Hubs have a responsibility to serve as referral centers for the Spokes in the region and provide consultation services to them as needed.





#### **H&SS** Description

- There are 19 Hubs located throughout California.
- The Hubs have the flexibility to choose their Spokes and structure themselves how they want, as long as it abides with the state guidelines.
- In addition to providing MAT services to patients in their clinic, the Hubs can also provide an array of services varying from transportation, harm reduction supplies, counseling and recovery support services.



#### What is a Hub?

- A Hub is a Narcotics Treatment Program (NTP) that specializes in treating patients with OUD.
- As a NTP, Tarzana Treatment Center's Inc. serves as a Hub and acts as a regional expert providing overall coordination and technical assistance to Spokes.



#### What is a Spoke?

- A spoke can be a Federally Qualified Health Center (FQHCs), Substance Use Disorder (SUD) treatment providers, mental health services agencies, correctional facilities, hospital, and other community-based service provider where a buprenorphine prescriber or potential prescriber is available.
- Spokes provide ongoing care for patients with milder SUD, managing both induction and maintenance, and have access to a dedicated MAT team.
- Spokes have the ability to refer patients with higher SUD needs to the Hub (e.g medical detox or residential rehab).



#### CA H&SS Implementation

The implementation of the CA H&SS will:

- Increase the total number of physicians, physician assistants and nurse practitioners prescribing buprenorphine.
- Increase the availability of MAT for patients with OUDs.

All Hub and Spokes must obtain or be currently enrolled in Drug Medi-Cal or Fee-for-Service Medi-Cal, as well as remain in good standing throughout the contract period.

### Learning Collaborative

- A Learning Collaborative (LC) is a critical component for the CA H&SS.
- The purpose of the LC is to engage CA H&SS provider and physician participants in the process of shared learning and experiences to facilitate implementation of services, assist with procedural changes, and provide opportunities for interactive problem solving.
- Six regional Learning Collaboratives have been established which meet on a quarterly basis, primarily as face-to-face meetings.
- UCLA is the LA LC host for this project.
