# Federal Ending the HIV Epidemic in America (PS20- 2010)

- 
- Liaison between CDC and the six Phase I Counties
  - Primary evaluator, currently customizing EPMP plans for each county
  - Building Healthy Online Communities(BHOC)
    - Facilitating funding for the TakeMeHome<sup>®</sup> program
    - Assisting the counties to utilize BHOC effectively within their EtHE Interventions
    - Reporting aggregate BHOC data for the six counties
  - Responsible for mid-year and annual reports
  - PS20-2010 fiscal management

# Speedbumps because of COVID

- 
- COVID documents took precedence, contract process slowed immensely at state and county level
  - Diverted staff delayed initiation of activities from posting for positions at the county through developing and issuing RFPs

## Other Speedbumps

- Award letter received day before start of grant
- Mobile Van Acquisition
  - CDC stated counties could not purchase vehicles, but the state could
  - State said it could not purchase vehicles, but counties could
  - Solution: ***Lease*** Vehicles

## **Current plan is the 2016 – 2021 California HIV Surveillance, Prevention and Care Plan**


- Data for 2016 – 2019 will be reported soon
- 12 Objectives, goal to eliminate disparities when identified

## **HRSA/CDC has issued instructions on creation of a new Integrated Prevention and Care Plan due in December 2022.**

- The new guidance recognizes that there are many other plans in effect, and those plans can contribute to fulfilling the requirements of the new 2022 – 2026 Integrated Prevention and Care Plan

# Ending the Epidemics Strategic Plan

- 
- The Office of AIDS and the STD Control Branch are developing the plan with community representatives from the Ending the Epidemics Coalition and others, and with the facilitation and writing skills of Facente Consulting
  - The intersectionality of Racial Health Equity, Social Determinants of Health and HIV, STIs and HCV will drive the plan.
  - The plan will use Harm Reduction principals and affirm the needs of people who inject drugs and people who use drugs, with emphasis of ending overdose deaths.



# Ending the Epidemics Strategic Plan will be developed in two parts

## **Year One: Mission, Value, Vision and Goals**

- Subject Matter experts providing guidance to the ETES Team
- Community Input through Surveys, key informant interviews, input of the statewide Ending the Epidemics Coalition
- A public comment period to provide input on the draft prior to finalization
- Release in December 2021


## **Year Two: Objectives directing activities to achieve the goals**

- OA and STD Control Branch staff guiding the development of objectives.
- Assuring compliance with HRSA and CDC requirements
- Consistent with the state's federal Ending the HIV Epidemic Plan, Part A plans, county Getting to Zero plans, etc.
- Ongoing community input and review periods






**BHOC Data: Sept 2020-June 2021**  
**HIV Test Orders by Jurisdiction (N=1651)**




### BHOC Data: Sept 2020-June 2021

HIV Test Orders by Age (N=1651)



**HIV Test Orders by Race (N=1651)**




HIV Test Orders by Gender (N=1651)





HIV Test Orders by Last Test Date (N=1651)





**Post Surveys by Jurisdiction (N=229)**




**BHOC Data: Sept 2020-June 2021**



# One key lesson learned

---

## **New programs take more time than anticipated**

- Contracts with CBO's may take longer than initially planned, have a plan in place to assist contracts, for staff, and for CBO's.
- Have a Plan B. We have participated in outreach and community testing events to begin testing while CBO's go through the contract process.



# Key Successes: HRSA Funded Activities

- Improved stability of medical care of dozens of individuals previously experiencing homelessness
- Provided validating, Trans-affirming care to dozens of Trans women
- Fortified trusting relationships which have led to viral load suppression and healthy and satisfactory gender affirming care and surgery outcomes (Trans Access)
- The shift to remote service delivery in response to COVID worked for some clients, reducing barriers to engagement in services such as transportation costs (Trans Access)
- EHE funded sites continued in-person care during COVID



# Key Successes: CDC Funded Activities

## Focused community engagement through mini-grants:

- 8 funded Community Advisory Processes (CAPs)
- Continuous and meaningful dialogue with the ETE communities
- Advise SFDPH on service design, delivery methods, and funding allocations
- Community leadership and skill building
- Meaningful compensation (at least 50% of the funding) to community members for their time and expertise

## Enhanced workforce development opportunities:

- HIV/HCV/STI Community Health Leadership Initiative (CHLI), focused on racial equity, health equity and harm reduction
- SFDPH workforce equity focus: hiring, recruiting, and supporting staff from ETE priority communities



# Key Successes: San Francisco City Clinic Project Expand and Elevate (ExEI) – Comp C

- Relaunched a phone-based PrEP Express Visit program
- Launched express visits for asymptomatic screening
- Research and planning toward implementing VL testing to help identify non-virally suppressed PLWH
- PrEP retention survey (low response rate but 1/3 of respondents said they were still on PrEP, in October 2020)
- Pursued EHE partnerships in the form of resumed sexual health public health detailing and TA to other agencies and clinics



# Key Innovations and Upcoming activities: HRSA

- Low threshold drop in services; more referrals from ER and Urgent Care; real-time availability of remote psychiatric consultations
- Trans-specific clinic days/times; one-stop shop model with onsite dental; hormone therapy as primary care
- Mobile medical services with street medicine overlap; support services in place to assist with keeping clients housed
- Home-based mobile blood draws (Forthcoming Program)
- Outreach and outpatient substance use treatment at homeless encampments; includes overdose prevention and service engagements (Forthcoming Program)



# Key Upcoming activities: CDC and HRSA

## Status neutral services (jointly funded by HRSA and CDC)

- Jointly funded navigators and other services and an expanded street medicine outreach team
- Services provided to both clients living with or at risk for HIV, HCV and STI
- Status-neutral, sex positive, whole person care messaging

## Mobile Contingency Management (jointly funded by HRSA and CDC)

- For people experiencing homelessness
- Focus on people who smoke fentanyl
- Street-based outreach and brief interventions
- Other resources: incentives, overdose prevention services, ongoing counseling, drug testing services

## Regional planning

- Collaboration with Alameda County Public Health Department, East Bay Getting to Zero, and SF Getting to Zero
- Develop regional PrEP approach and messaging




# *Ending the HIV Epidemic Initiative:* **Los Angeles County Updates**

**Overarching Goal:** Reduce new HIV transmissions and acquisitions in the United States by 75% in five years and by 90% in ten years.

**Overarching Strategy:** Ensure that Los Angeles County Ending the HIV Epidemic pillars of interventions address and eliminate health inequities, address and dismantle racial inequities that are at the root of HIV and related syndemics, focus on the communities most impacted by HIV, and adopts a client-centered, people first approach.

**Priority Populations:** Based on the most recent LA County epidemiologic profile and other key local data, the priority populations include: Black/African-American men who have sex with men (MSM), Latinx MSM, women of color, people who inject drugs, transgender persons, and persons under 30 years of age.

**HIV Testing Brief in development.** Identifies County testing access points and modalities and include guidance on how to increase HIV testing across sectors.



**HIV testing in healthcare and other institutional settings in high prevalence communities.**

- Working with DMH to conduct rapid HIV testing in clinics.
- Ongoing discussion with partners to expand test kit distribution; routine opt out testing.

**Expanding HIV testing in non-healthcare settings through HIV self-test kits.**

- DHSP Orasure test kit distribution to date:
  - 1,753 to testing providers.
  - 2,055 distributed at June community events.
  - 1,044 at additional community events.
- *Take Me Home* Partnership: 1,130 tests ordered as of June 2021. 83% identified as men, 56% under 30 years, 46% identified as Latinx, 65% haven't tested in over a year and 35% never tested.

## **Rapid Linkage to Care Pilot Program launched** with 3 sites at Wesley Health Centers (Hollywood, Pasadena, Hacienda Heights) & 2 testing sites (LA CADA, REACH LA).

- Protocols developed and close to final.
- HIV navigators to be hired at DHSP.
- Warm line created.



**Emergency Financial Assistance Program** offers up to \$5,000 available to eligible clients to be sent directly to vendors for emergency situations related to rent, utilities, food, etc.

- Network of over 35 providers trained.
- 217 of 323 applications approved to date, 91 pending, 14 withdrawn/referred.

**Ryan White Mental Health Assessment** in development.

- DMH collaboration in development to increase services at 3 sites: Augustus Hawkins, Edelman, Hollywood.
- Exploring potential for region-wide telehealth mental health services with emphasis on the monolingual Spanish speaking community.

**Contingency Management Pilot Program** developed for two cohorts.

1. Youth – status neutral approach
2. Women out of care from DHSP’s Linkage and Reengagement Program

**HIV Transition of Care Program in development** with LAC USC Medical Center and USC Street Medicine.

- Proposed model will bring acute care providers (ED, Inpatient) in closer collaboration with street medicine and outpatient HIV services.

**Ongoing Discussions:**

- Workforce development for PLWH
- Peer to Peer linkage to care programs

## **PrEP Landscape Analysis with Clinics/Providers in District 2 (South Los Angeles region)**

- Preliminary results: 30 completed interviews, 66% offer PrEP to patients, 56% unaware of CA law requiring PrEP insurance coverage, 41% identified a training need.

## **TelePrEP to increase retention and engagement**

- 3 telePrEP partnerships executed with Via Care, St. Mary's, Wesley Health Centers.

## **Client Follow Up to Support Linkage to PrEP**

- Conducting calls to people recently diagnosed with syphilis.

**Increase capacity of Syringe Service Programs via SAPC partnership to link PWID to HIV prevention.**

**PrEP marketing campaign discussions with community.**



## **Cluster Detection and Response Plan in development.**

- Refining processes and real-time cluster detection response.

## **Increase capacity to provide Partner Services to all people newly diagnosed with HIV.**

- Hired additional Public Health Investigators (PHIs) to support both Partner Services and the Linkage and Re-engagement Program.

## **Build surveillance infrastructure to enhance the identification and assignment of new HIV cases to staff for timely follow-up and Partner Services.**

- Contractor selected to support development of procurement for new data system.
